When she began the Self-Sufficiency program, Corrine was unemployed, working to finalize her divorce, and had a high school education. Over the past six months, Corrine has hit the ground running. During this time, she has been self-representing against her husband, was accepted into school at a local community college, and was approved for FASFA grants to cover this cost.

Not only has Corrine been a full-time student, but she also secured a part-time job with Comcast that allows her to work from home and tend to her infant during the day. As Corrine begins the second half of her journey through the Family Self-Sufficiency program, she is completing her program requirements and looking for an additional part-time job to increase her savings during her time with us. With her drive and determination, we anticipate that Corrine will not only meet each goal she has set for herself, but will exceed them.








PIH FY 2021-22 Income \$3,421,813

THE CHALLENGES OF FAMILIES IN OUR COMMUNITY.

In Colorado, the Fair Market Rent (FMR) for a two-bedroom apartment is \$1,505. In order to afford this level of rent and utilities — without paying more than 30% of income on housing — a household must earn \$5,016 monthly or \$60,186 annually
